I acknowledge that

The Vintage Bike Ride is a project of the Rotary Club of Rutherglen Incorporated.

The **Event** is the Vintage Bike Ride;

The **Event Owner** is The Rotary Club of Rutherglen Incorporated. **(Rotary)** The Rotary Club of Rutherglen Incorporated is an association of volunteers who are not paid.

I am, and any people registered by me, and other Participants are the **Participant/s** or **Ride Participant/s** and/or **the Event Participant/s**

These Terms and Conditions are designed to enable the Event to operate smoothly, safely and effectively.

By registering to participate in the Event, I accept and agree to be bound by these Terms and Conditions of Entry in respect of myself and any other persons, including any minors or children whom I register. I further warrant that I have authority to agree to these Terms and Conditions of Entry on behalf of all those persons

Safety

I understand that cycling on roads is a potentially hazardous activity and involves the real and foreseeable risk of serious injury or death from matters including, but not limited to, accidents with other road users (whether cyclists or motorists), road and weather conditions, equipment failure and the effects of strenuous exertion and activity.

I am aware and acknowledge that the Event involves inherent risks, including the risk of injury to life or death and damage to property and in undertaking such activities, I do so at my own risk, and that I am responsible for any loss or damage which I may cause.

The Participants shall abide by the road rules of Victoria, obey any directions of Police, and/or the Event Owner and shall ride with care and consideration of other road users and Event Participants. I also understand that many of the roads, albeit some are unsealed, are designed for the traffic of motor vehicles, and may not have any designated Bike Lane.

During the Event, at all times, the Participants shall

a) wear a cycling helmet with straps fastened that complies with the relevant Australian design standard; and

- b) wear a highly visible jersey (preferably yellow) or sash and
- c) display a red flashing light at the back of the bicycle.

Any children or minors accompanying Event Participants must also wear and have fastened a cycling helmet that complies with the relevant Australian design standard.

Riders under 18 years of age shall be accompanied by a nominated adult Ride Participant who will be responsible for their welfare.

The Event Organiser recommends that at all times I have access to a mobile phone.

Personal Responsibility

I am responsible for all my personal property brought with me (including my bicycle.) I understand that the Event Owner does not accept any responsibility whatsoever for any loss, damage or harm caused to my personal property.

The Event Owner strongly recommends that I obtain personal accident insurance before taking part in the Event. The Event Owner also recommends that my bicycle is checked and serviced by a bicycle mechanic prior to using it in the Event.

I shall not participate in the Event if I am aware that I have contracted Covid 19 or any other transmittable disease.

In the event that the Event Owner deems it appropriate for my safety or the safety of others, the Event Owner may, at any time, in its absolute discretion, direct my withdrawal from the Event.

Cancellation or withdrawal

The Event Owner reserves the right to cancel the Event at any time. The Event Owner is not liable to the Participant for any loss, damage, cost or expense of any kind including, but not limited to, refund of entry fees, or any other expenses incurred by the Participant.

The Event Owner is under no obligation to refund monies or entry fees due to my non-use, cancellation, failure to participate or directed withdrawal.

If the Event Owner decides to exercise its discretion and cancel the event, the Event Owner will endeavour to publish the decision on the Event's website <u>www.rutherglenrotary.org</u> as soon as practicable after the Event has been cancelled.

Privacy and Photography of Participants, including Minors

The Event owner collects my personal information so that I may enter the Event.

Rotary may use or disclose my personal information for any purposes relating to the Event.

I consent to the taking of images or video footage of the Participants during the Event by the Event Owner or its authorised agents and authorise the use of such images or video footage by the Event Owner, in all forms of media.

Indemnity and Release

I indemnify Rotary, its officers and employees, agents and volunteers against all loss, damage and expenses arising out of or in connection with any claims, actions, proceedings or demands of any kind arising directly or indirectly as a consequence of my/our participation in the Event.

I release Rotary, its officers and employees, agents and volunteers from all liability, howsoever arising, from injury or damage to both property and person howsoever caused (whether fatal or otherwise) arising out of the Participant's participation in the Event whether or not such injury or damage is due to any negligent act, breach of duty, default and/or omission on the part of Rotary, its officers and employees, agents and volunteers, or by any other Participant.
